*I've only owned my property for 9 months. Haven't been out on the lake yet. Hard to answer some of these questions.*

*It is no longer worth living on Bone Lake. Taxes are out of sight and the Indians have ruined the eco-system of the lake. They slaughter the Muskies by the hundreds. We pay the taxes!! Know people who have sold and said they thought they hit the lottery as they didn't have to pay the taxes anymore. Start concentrating on taxes and putting fish back in the lake or no one will even use it anymore. Stop pretending in the newsletter like these subjects don't exist.*

*The fireworks should be shot off from a central lake location. The North End is dangerous if you live on the South End--too many boats at too high speeds in the dark.*

*Can we get Balsam Lake Snowmobile Club to mark Bone Lake in winter? Many many snowmobiles complain about Bone not being marked. It provides safety and direction to people that have never been on Bone--even those families with Bone would like cones to mark lake from north to south. I volunteer my service to Balsam Lake Club and no one called me. I would be happy to help even keep cones and mark it myself. I hate weeds and weed lined shorelines. If I wanted to look at weeds on shoreline I would not be on Bone and pay these outrageous taxes.*

*Installed DNR cribs in the lake each winter - I would help with this; stock walleye fingerlings each year for five years, determine whether they would be self sustaining - I would help with this; determine why pan fish seem to be stunted in size, figure out how to grow them larger; don't allow power loading of boat at north landing or make a second landing or triple widen the existing landing, have one for non power loading and/or one for power loading.*

*I don't think I could help with this survey. We only use the land to deer hunt. Maybe 2 days a year.*

*Noise level is bad from loud radios and dog kennel.*

*I was on the council but voted off so have felt it best I not attend. Bone Lake is a high quality lake that needs to be managed for multiple use, fishing, water recreation, swimming, water skiing, etc. But at the same protected for long term use of these multiple uses in years ahead. I'm always concerned when a one-user type, fishes, wildlife, naturalist, environmentalist, etc has a greater influence on how the lake is managed. I appreciate the opportunities to express in an open forum my personal opinion, and hope they have an impact on the future of Bone Lake. After 50 years, I believe I have something to contribute.*

*Just purchased cabin, spending most of the time remodeling so not qualified to answer some questions.*

*Do not wish to volunteer at this time, but maybe at a future date.*

*Major issues we need to deal with: 1 - algae blooms/water clarity; 2-There are many unsafe boaters, someone is bound to be killed, the issues are driving fast by docks and driving fast by other boats, MN boaters seem to be better educated about distance laws than WI boaters; 3-Our fish management is awful, lakes large and small around Bone have much better variety and abundance of fish, the obsession with Muskie is part of the problem, we should allow and promote/stock other species for sports and consumption, crappie, bass, pan fish, walleye, why does the DNR create 1 specie (Muskie) lakes and then allow that specie to go extinct via spearing? It spoils the lake for those who own and pay for the enjoyment.*

*Part-time resident - No more spearing by Indians, ruining musky fishing.*

*Concerned about jet skis and lack of regulations.*

*Too old for meeting, volunteering, don't have a computer.*

*Planning on retiring year around.*

*We are very grateful for the amazing increase in volunteer activities over the last 10 years on Bone Lake. Thank you for your time!*

*Live two hours away.*

*Not at this time, still employed full time.*

*Having enjoyed time spent on Bone Lake my entire life, I have become extremely disappointed with the lack of respect for peace and quiet. The constant sounds of fireworks being shot off year round, the traffic noise both on the lake and surrounding roads and people blasting music have become the norm rather than the exception. During holiday weekends we typically stay in the city and find it much quieter. We were planning to retire at the lake for 6-7 months of the year, but now realize it would be anything but relaxing. We have contacted a realtor and are seriously considering selling the property.*

*Just moved in.*

*One number one priority at north boat landing stating no boat power loading. Over the years, a lot of money and work has been done only to be undone by power loading boaters whom are careless and irresponsible.*

*There needs to be a curfew for jet skis and water skiers. I have been fishing in early am and have jet skis already out. I have fished in late to dark evenings and had water skiers and jet skiers continue to be out well after they should not. They seem to be drawn to someone fishing and most will pass by close a lot. There should be no jet ski or water skiing from 8 pm to 9 am to let people who want to fish be able to in peace for a while. It is not fun to be bouncing all the time. Boat regulations need to be enforced with fines. Boat and jet skis pass by my dock sometimes within 20 feet at high speeds. Need to look for boats before jumping off the dock.*

*Really need to do something regarding the fishing tournaments. Every time there is one, it's virtually impossible to sit on your dock without somebody casting and just about hitting you. They don't seem to care if you're there or if you are fishing on your dock. They cast right next to you and hit the boats. PLUS, there're not good about going to the landing to use the bathrooms, they just go to the back of the boat and go in the lake. In addition, whenever there's a bass tournament, and they do a weigh in at the north landing, we find multiple dead big bass in the following weeks washing up on our shore (we're south - across the lake from the landing). I wonder what happens to these bass that they catch from all over the lake and then after the weigh-in they release them all at the north end. Can't be good for the bass population.*

*I have donated to the fireworks for years and being at the south end can rarely see very much of it. The last few years, my 4th of July friends and guests have donated to the fallen heroes fireworks at the south end. The fireworks are great and it goes to a good cause. Why not have everyone donate to these fireworks and consider not having them at the north end.*
