COMMITTEE REPORTS

Watershed Runoff - Phil Foster

Holding ponds above 250th St. are still flooded. Christensen's area dams baking up. Beaver are blocking overflow and trapping the beaver is underway.

Waterfront Runoff - Alex Chorewycz

Wilkins project: DNR has approved waterfront mitigation including holding pond and grading from parking lot to the lake. Cheryl Clemens has been helpful moving the project forward. Due to Covid-19 conditions, Wilkins has put the project on hold. Wilkins, DNR and the District are working together to finish the project this year. Waterfront runoff with property owners: newsletter will promote Mary and Cheryl's consulting.

District-funded Septic Incentive is still available, limit of five granted per year. If holding tank is taking on water it is not considered a failing system. If drainfields are flooding, the system is non-compliant and could be eligible for the District incentive.

Fisheries - Bob Boyd

Repairing fish cribs moved by ice. Still monitoring smallmouth reproduction and sizes being caught.

Aquatic Plant Management — Bob Boyd and Cary Olson

Thanks to Cheryl Clemens and Steve Schieffer for working with us to draft the well-written document. We tightened up a lot of language to cover unknowns and new invasive species, how to determine treatment of CLP and navigation channels, how property owners can treat their own properties with permitting. CLP contract for this year has been issued. Waiting for Tribe harvesting to be completed. After that and when water temp and wind conditions are right treatment will begin.

Clean Boats Clean Waters - Bob Boyd

Program is on hold due to Covid-19 restrictions. Monitors are ready when they can be allowed. Statewide, monitors are on hold. Landing cameras are starting up.

Boating Safety - Mike Musial

Buoys are ready and will be installed in critical areas first; all will be in place before fishing opener. Docks: New dock on North Landing. South end dock was damaged, old north end dock will not work there. Noah knocked down the sand and ice berm but other work needs to be done to level the ground so the dock can be installed. Mike repaired the dock at cost of \$1,600. Some money can be gained from sale of north end dock to offset the; not sure of value. John Ukura agrees to sell north end dock. New north end dock will arrive on Wednesday, April 29. Ron Ogren says Town of Georgetown will help as part of their services to work on the lake substrate to level it. Phil will send Town info to Mike to coordinate. North end fishing pier is already installed.

<u>Motion:</u> Mike Musial to repair south landing substrate following Town of Georgetown's capacity. Mike will provide projected costs prior to proceeding. Chorewycz/ Motion was not seconded.

Motion: Sell north end dock to offset cost of south end dock repair. Musial/Chorewycz

Send eNews update on buoys, docks, landings, boat safety.

South landing safety: Outhouse.

<u>Motion:</u> Place and pay for an outhouse from Olson Sewer Service at the south landing for the time period of May 15 - October 15. Musial/Chorewycz. Carried.

Wildlife and Natural Beauty Committee — Karen Engelbretson

New members: David Klopp, Teri Albright, Kay Banister Schafer. Purple martin initiative: Install refurbished houses donated by David Klopp. <u>Motion</u> Appropriate \$750 from Wildlife and Natural Beauty Committee budget to pay for purple martin house installation. Engelbretson/Musial. Carried.

Communications - Karen Engelbretson, Chair

Spring Bone Lake Newsletter content was reviewed as presented. Fireworks will be on July 4th. Owens setting up a 501(c)(3). Thank your to our advertisers. Add APM article, Cary will write. Alum FAQ - leave out anything on fisheries at this time. Impact of alum on fisheries is uncertain. FAQs is first of a number of alum committee communications.

Fisheries will be included later. County board report could add something about the CAFOs but things are changing daily. Mike: not recommending Kids Don't Float kiosk use at this time due to Covid-19.

Reduced Wake - Cary Olson, chair

Response from e news recruiting wakeboat owners added a few new committee members, T. Poeling, A. Koester, J. Owens. Committee also includes J. Ukura and ______. Make known legal distances from shoreline for wakes. Add buoys for 100 ft from shore to illustrate distance. Cary will get committee going right away. Mike was asked to place a buoy at the location where a homemade temporary buoy might suffice. Mike could take an old buoy and paint our own signage on it and move around the lake. [Sec. note: legality of these buoys?]

Alum Committee — Phil Foster, chair

Several meetings of committee and finance subcommittee over the winter. Four items in addition to communications plan. Alum cost projections have gone up. Alum comes from China, tariffs and instability in prices. Alum prices are expected to go up 3% above normal inflation for material.

- 1. Treatments: Was 40/30/30 over 6 years. Recommendation now is 30/30/20/20 of dosage of 100 gallons per meter over 9 years instead. More benefit, subsequent treatments go out to 19 or 20 years.
- 2. How to pay for it: Bank financing has additional cost. Pay as you go approach would postpone treatments one year to build up cash. Summary on Alum costs document illustrates costs and payments.
- 3. Contingency: contingent on receiving one DNR grant of \$200K.
- 4. Exempting back lot property owners: 560 property owners, 70 properties do not have direct lake access (12% of owners) representing 5% of the value. Excluding these property owners increases the tax 5% to other property owners. \$122 to \$130 per 100K of value. Reasoning is that back lot owners do not have same direct benefit. Requires a special assessment category, not part of Bone Lake District tax. Over ten years.

Discussion:

- All approaches assume \$200K from District funds which is not on the document presented to the Board. Suggested that the amount be included on documents presented to District members.
- All District members including those on back lots pay District taxes equally for lake improvement activity.
 Considering excluding backlot owners from the alum tax yet they can vote for it.
- If it is not a District tax then back lot owners could be excluded from the vote on using alum.
- Pay as you go timing with four applications, 30 gal. vs. 40. Will the first treatment be effective? Bill James says it will work at that dosage.
- If using 3 treatments would need to wait 3 years to begin.
- Once we begin a 9- to 10-year tax, we're in it. We do have the right to stop treatment should the District members vote for it.
- If 2021 annual meeting vote to use alum is passed, tax would be included and payable on 2022 tax statement.
- Expected water clarity improvement has been projected in committee communications as 3-4 feet. Actual average over the year is 2.6 ft., or 3 feet in late summer. Communications should be clear on where figures come from.
- · Include citations FAQs.
- Other citations mentioning water clarity and property values should be included.
- Stating "potential improvement of approximately 3 feet of water clarity" is acceptable.
- Any final motion on using alum would include the 4 points above and the 4 points will be communicated to District members.

<u>Motion:</u> Use the four points above for communciations going forward over the next year assuming the alum treatment objective continues. Foster/Chorewycz.

Discussion:

Suggest "pay as we go" for terminology. Agreed.

Simplify information to property owners about the assessment and payments.

Include detailed spread sheets on the Bone Lake website. New material can be added.

Motion carried.

OLD BUSINESS

Move to table old business agenda item: Policy document to approve chair description and establish vice chair role.

NEW BUSINESS

Alum treatment

Motion: Cancel scheduled alum treatment vote at 2020 annual meeting and instead do a late summer 2020 BLMD survey if we should have an alum treatment vote at the 2021 annual meeting. Foster/Chorewycz.

Discussion:

- How will survey be conducted. Online. Enews. Postcard to sign in to do an online survey generated 50% response for Cedar Lake. Plans for survey are not finalized.
- A late summer survey may be better generated in November. Is late summer timing intended to coordinate with algae bloom? Late fall would give a better look at conditions.
- Families with children returning to school and college are busy late Aug and early September. Later in September might be better timing.
- Postcard mailing would cost \$350.

Motion carried.

Approve updated APM Plan

Motion: Approve updated Aquatic Plant Management Plan. Engelbretson/Chorewycz.

Discussion:

- Does the plan include a navigation channel for the north end? Yes. Was approved in the permit. Markers will be placed for treatment area this spring.
- Public comment received from Atkinson requesting treatment in a sensitive area fits into the planning we wrote
 into the plan and is an example of how we would act on a request like this. This summer we can survey the plant
 population in that area to quantify the amount of CLP.
- Treatment for 2020 is already established.
- Thank you to those who attended the committee meetings and doing the hard work. Thank you to Cheryl Clemens and Steve Schieffer for their expertise and leadership.

Motion carried.

TOWN AND COUNTY REPORTS

Supervisor Doug Route, Polk County report

At the ESC Committee, a subcommittee has been created consisting of LWRD, Zoning and the Health Department. The report provided on Wednesday will be discussed in the next few meetings. Moratorium on CAFOs: Criticism is that the committee has only created a 1000 ft. shoreland protection area around the lakes precluding a CAFO although more has

been done including conditional use permits. Can't stop a CAFO but controls can be put on them. State government also has rules. Conditional uses are all the county can do. The 1000 ft. protection area from a lake is considered a big step and a start. ESC committee meetings are filmed and available on YouTube.

Concerns for water quality are big issues. Movie Right to Harm is available online.

The process has been very difficult. Doug is opposed to CAFOs and suggests people contact those supervisors who are in favor of CAFOs. Send emails to county clerk. Call supervisors.

Andy Brown, Chair, Town of Bone Lake report (read by Karen Engelbretson)

As many of you know the dam project on the Straight River ended up needing to be redesigned and rebid last October. The bids came back and raised the overall cost of the project significantly. On a split vote the town board decided to end the project due to excessive costs. This was a tough decision and the culmination of years of hard work by many people. The Straight River will continue to flow into Big Round Lake at its current level without restriction.

On a brighter note, the old narrow culvert/bridge over the river was replaced with a new wider metal culvert and guard rails and the road will be repaved this May or June. Our beloved Town Clerk, Darrell Frandsen, has announced that he will retire in April of 2020 and we'll begin looking for his successor soon. Our clerk is appointed by the board not elected by the voters. The township thanks the Luck Lions Club especially Gerry Albright for the work that they do maintaining Don Langel Park (north landing).
