Cary Olson called the meeting to order at 1:59 p.m.

Cheryl: quick summary of potential Harvester grant funding via email August 15, 2023.

All \$ for inland waters (not Great Lakes) were distributed in the first meeting of the Waterways Commission in August 2023. There was \$2 million available and 3.5 million in funding requests. 1.2 million was available for inland waters. The upcoming cycle (due Sept. 1) for the Nov. Waterways Commission meeting has funding available only for Great Lakes projects.

If some of the funding awarded in August 2023 is not used, there may be inland waters funding available at the April meeting. Pat thought they would know this by Sept. 1.

BLMD could submit an application at any time. A harvesting permit (completed not just the application) must be included with the grant request. If you want to submit an application for the April 1, 2024 deadline, you could proceed with a harvesting permit in Sept. It is most likely that \$ will be available beginning July 1, 2024. In the meantime, Pat is willing to review a draft application.

Grant money is gone. 1.2 million dollars were used on Lake Winnebago and in Waukesha County. There may be money available in April, 2024. New fiscal year starts July 2024, meeting is in August. Timing after that is unknown, but likely harvesting could begin in 2025. A 50 percent grant can be anticipated if the project gets funded.

Another procedural step: A DNR approved APM harvesting permit would need to be approved to begin harvesting. \$300 fee for one year. Continue working on submitting grant September 1.
